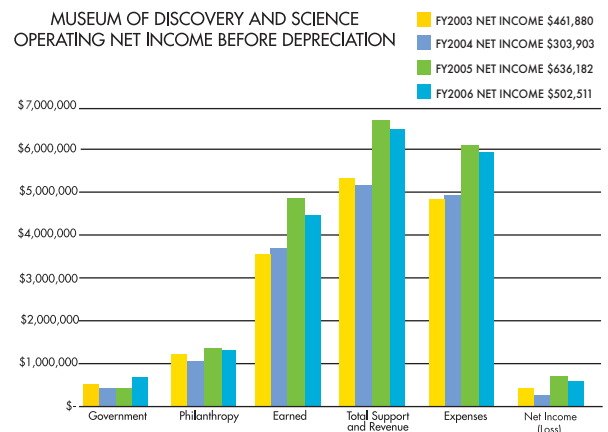

## Fiscal Year 2006

- Hurricane Wilma hit the Museum hard, forcing the Museum to close for over a week, causing serious damage, and depressing attendance from a community of people absorbed in house repairs and recovery. In spite of this setback, the Museum completed a highly successful fiscal year, generating net income over expenses of \$502,511, far better than budgeted expectations.
- The Museum has an operating budget of \$6.5 million in revenues and an operating endowment of over \$3.9 million in assets.
- 68% of revenues were generated through earned income from admissions, program fees, sales, and interest from endowment; 22% came from philanthropy; and 10% from government grants.
- Total attendance for Fiscal Year 2006 was 382,287.
- The Museum's endowment produced 48% more income than prior year due to positive results in the investment market.
- In spite of the loss of bookings and revenue due to Hurricane Wilma, and school closings of nearly a month that caused cancellation of many planned field trips, the Museum's school and group bookings were down only 6% from prior year.
- Earned income from program fees increased by 9% over prior year, with increases in birthday parties, camps, overnights and turtle walks.
- Philanthropy and event revenue remained within 1% of prior year's totals, at nearly \$1.4 million.
- The Museum received over \$1,000,000 of in-kind support in FY 2006.
- Corporate and foundation contributions increased by 5% over prior year.
